### **Postdoctoral Fellowship Duties and Opportunities**

- All virtual postdoctoral fellowship with limited in-person options available
- Approximately 15-20 clinical hours per week with a diverse caseload of clients
- Flexible work schedule with the postdoc (and client need) determining when they work
- Opportunities for training in evidence-based treatments for PTSD such as Cognitive Processing Therapy (CPT), Prolonged Exposure Therapy (PE), Eye Movement Desensitization and Reprocessing (EMDR) and evidence-informed treatments such as Acceptance and Commitment Therapy (ACT), Cognitive Behavior Therapy for Insomnia (CBT-I), Dialectical Behavior Therapy skills (DBT), Written Exposure Therapy
  - \*Training in these therapies is subject to supervisor availability
- Opportunities to run workshops and groups and/or participate in community outreach
- Weekly clinical case consultation with licensed therapists and trainees
- Monthly didactic trainings on topics pertaining to PTSD and psychotherapy
- Potential to supervise and/or provide mentorship to trainees
- Opportunity for program development/program evaluation/organizational management

### **Postdoctoral Fellowship Logistics**

- Salary for 2025-2026 year is \$56,000; paid biweekly (using the federal pay calendar) via direct deposit
- 4 weeks (20 days) of paid time off plus 5 holidays
- Health insurance will either be provided by DC Health **or** a stipend of commensurate amount will be added to those that need health insurance coverage from their place of employment
- Access to Microsoft Office 365 (outlook, TREC DC email, TEAMS, and share drive of therapy materials)
- Access to electronic health record system with telehealth capabilities
- Weekly individual supervision with licensed clinical psychologist for licensure in the DMV and support if postdoc is seeking licensure in a different jurisdiction
- 1 hour of group supervision/week through clinical case consultation meeting
- Monthly mentorship meetings for professional development
- Opportunity to be an integral part of the selection and interview process of incoming trainees
- Postdocs will maintain active Psych Associate licenses in **both** DC and MD. TREC DC will reimburse the cost of the MD license and the postdoc will cover the cost of the DC license
- Malpractice insurance will be covered and maintained by the postdoc
